Stiferite PENDENZATO GT is a composite panel made by a base side EPS and a top side based on Stiferite GT, expanded rigid polyurethane foam, covered on both sides by multi-layer facer, and produced by Stiferite. The EPD applies to 1 m² of 63 mm thick PUR sandwich board and 30 mm thick EPS slope board, i.e. 0.093 m³, with an average density between foam and facing of 32.4 kg/m³.

Scope:

Stiferite produces StiferitePENDENZATO GT which is a high performance composite insulation board manufactured from a top side a closed cell expanded rigid polyurethane foam, covered on both sides by multi-layer facer, and a bottom side an EPS insulation panel with a slope shape. The data have been provided by the only Stiferite factory that is located in Padova (Italy) for the year 2021 and sold worldwide. The owner of the declaration shall be liable for the underlying information and evidence; the IBU shall not be liable with respect to manufacturer information, life cycle assessment data and evidences.

The EPD was created according to the specifications of EN 15804+A2. In the following, the standard will be simplified as *EN 15804*.

Product

Product description/Product definition

Stiferite's thermal insulation panels are mainly used in the building/construction sector and in industrial insulation.

The panels are made of thermo-setting closed cells polyurethane foam (PU) supplied with various types of flexible facers on both sides of the panel. The nature/type of facer is a function of the type of panel and its application.

Expanded rigid polyurethane foam is distinguished by its thermal insulation performance, mechanical resistance, workability, lightness, and durability.

The performance of Stiferite's panels is determined based on the European norm *EN13165:2012+A2:2016* Thermal insulation products for buildings - Factory-made rigid polyurethane foam (PU) products - Specification.

This EPD refers to Stiferite's PENDENZATO GT average thick panel, made of an insulation component in polyurethane foam using blowing agent Pentane-based, covered on both sides by multi-layer facer, and on the bottom side of an insulation component in EPS with a slope shape. The panel is produced in standard dimensions of as requested by the customers and straight finish borders.

Stiferite PENDENZATO GT panel is produced by a certified company with systems: *ISO 9001*, *ISO 45001*, *ISO 14001* in its entire line of products.

Application

The Stiferite PENDENZATO GT panel is suitable for the insulation of flat roofs under synthetic mantles in-view or weighted down and under bituminous mantles applied cold (not torched).

Base materials/Ancillary materials

PU insulation panel: (about 65.2 % of the weight of the declared unit)

Close cell Polyiso (PIR): rigid foam made from MDI (50-65 %), polyols (20-30 %), pentane (4-6 %) and additives (4-6 %).

PU Facing (about 5.1 % of the weight of the declared unit): multi-layer facer consisting of aluminium (10-20 %), kraft paper (60-70 %) and PE layer (10-20 %).

EPS insulation panel: about 29.7 %

Reference service life

The durability of insulation panels is normally at least as long as the lifetime of the building in which it is used. The experimental data show that the reference life is greater than 50 years.

The declared unit is 1 m² with a thickness of 93 mm, e. g. 0.093 m³.

thermal insulation board. The life cycle is split into the following individual phases:

A1 - Raw material formulation

A2 - Raw material transport

A3 - Production of the insulation board and packaging material

A4 - Transport to the construction site

C1 - demolition and deconstruction

C2 - Transport to end of life

C3 - End-of-Life: waste management (thermal recovery)

C4 - End-of-Life: waste management (landfill)

D - Benefits and loads beyond system boundary

Disclaimer 1 – for the indicator “Potential Human exposure efficiency relative to U235”. This impact category deals mainly with the eventual impact of low-dose ionizing radiation on human health of the nuclear fuel cycle. It does not consider effects due to possible nuclear accidents, occupational exposure or radioactive waste disposal in underground facilities. Potential ionizing radiation from the soil, radon and from some construction materials is also not measured by this indicator.
