Stiferite RP consists of a polyiso (PIR) rigid foam panel, covered with multi-layer gas diffusion tight facers on both sides and integrated vapour barrier on the hot side, bonded to a 13 mm plasterboard (CG), and produced by Stiferite. The EPD applies to 1 m² of 77.8 mm thick PUR sandwich board, i.e. 0.0778 m³, with an average density between foam and facing of 153 kg/m³.

Scope:

Stiferite produces Stiferite RP that is a high performance insulation board manufactured from closed cell expanded rigid polyurethane foam, covered on both sides with multi-layer gas diffusion tight facers and integrated vapour barrier on the hot side, bonded to a 13 mm plasterboard. The data have been provided by the only Stiferite factory that is located in Padova (Italy) for the year 2021 and sold worldwide.

The owner of the declaration shall be liable for the underlying information and evidence; the IBU shall not be liable with respect to manufacturer information, life cycle assessment data and evidences.

The EPD was created according to the specifications of EN 15804+A2. In the following, the standard will be simplified as *EN 15804*.

Product

Product description/Product definition

Stiferite's thermal insulation panels are mainly used in the building/construction sector and in industrial insulation.

The panels are made of thermo-setting closed cells polyurethane foam (PU) supplied with various types of flexible facers on both sides of the panel. The nature/type of facer is a function of the type of panel and its application.

Expanded rigid polyurethane foam is distinguished by its thermal insulation performance, mechanical resistance, workability, lightness, and durability.

The performance of Stiferite's panels is determined based on the European norm *EN13165:2012+A2:2016* Thermal insulation products for buildings - Factory-made rigid polyurethane foam (PU) products - Specification.

The performance of Stiferite's composite panels is determined based on the European norm *EN 13950:2014* Gypsum board thermal/acoustic insulation composite - Definitions, requirements and test methods.

This EPD refers to Stiferite's RP average thick panel, made of an insulation component in polyurethane foam using blowing agent Pentanebased, covered on both side with multi-facer gas diffusion tight and integrated vapour barrier on the hot side, bonded to a 13 mm plasterboard. and bonded to one side with 13 mm thick plasterboard. The properties of Stiferite RP panel components ensure excellent reaction to fire (European B-s1,d0 class) The panel is produced in standard dimensions of 1200 x 3000 mm and straight finish borders.

Upon request and for minimum quantities, the panels may be produced in various dimensions, and the borders may be rabbeted along the sides. The surface of the panel may be evened out with sandpaper in order to allow installation on uneven surfaces. Stiferite RP panel is produced by a certified company with systems: *ISO 9001*, *ISO 45001*, *ISO 14001* in its entire line of products.

Application

The Stiferite RP panel is suitable for insulating. Walls and Ceilings applications from the inside.

Base materials/Ancillary materials

Core material (about 17.1 % of the weight of the declared unit):

Closed-cell Polyiso (PIR) rigid foam made from MDI (50-65 %), polyols (20-30 %), pentane (4-6 %) and additives (4-6 %).

Facing (about 1.3 % of the weight of the declared unit): multi-layer gas diffusion tight facers consisting of PE (10-20 %), aluminium (15-25 %), and paper (60-70 %).

Additional panel (about 81.6 % of the weight of the declared unit): plasterboard (95-99 %) and glue (1-2 %).

The PU board for insulation:

Additional declaration according to quoted law: The product is compliant with all requirements indicated in chapter 2.5.7 'Isolanti termici ed acustici' of the n.256 D.L. of the 23th June 2022 (CAM EDILIZIA):

- Any blowing agent with Ozone depletion potential >0 is not used in production
- Any substances of Very High Concern-SVHC in concentration of more than 0,1 %_w are not used in production (REACH n. 1907/2006). Reference service life

The durability of insulation panels is normally at least as long as the lifetime of the building in which it is used. The experimental

data show that the reference life is greater than 50 years.

- A3 - Production of the insulation board and packaging material
- A4 - Transport to the construction site
- C1 - demolition and deconstruction
- C2 - Transport to end of life
- C3 - End-of-Life: waste management (thermal recovery)
- C4 - End-of-Life: waste management (landfill)
- D - Benefits and loads beyond system boundary

Disclaimer 1 – for the indicator “Potential Human exposure efficiency relative to U235”. This impact category deals mainly with the eventual impact of low-dose ionizing radiation on human health of the nuclear fuel cycle. It does not consider effects due to possible nuclear accidents, occupational exposure or radioactive waste disposal in underground facilities. Potential ionizing radiation from the soil, radon and from some construction materials is also not measured by this indicator.
