PRIVACY - USE OF COOKIES

The data controller **Stiferite S.p.A.**, pursuant to Articles 13 and 14 of Regulation (EU) 2016/679 and Italian Legislative Decree No. 196/03 as revised by Italian Legislative Decree No.101/2018 concerning the protection of natural persons with regard to the processing of their personal data, hereby would like to inform you about the following:

WHAT ARE COOKIES

Cookies are made up of portions of code installed in the browser that assist the owner in providing a service according to the purposes described. The installation of some cookies may also require the user's consent. While browsing a site, the user may also receive cookies on his device that are sent by different sites or web servers (the so-called "third parties"), in which certain elements (for example images, maps, sounds, specific links to pages of other domains) present on the site that the user is visiting may be found. Two macro-categories can be identified: "technical" and "profiling" cookies.

When the installation of cookies is based on consent, this consent can be revoked freely at any time by following the instructions contained in this document.

Technical/analytical cookies

These cookies are used for the sole purpose of 'carrying out the transmission of a communication over an electronic communications network, to the extent strictly necessary for the provider of an information service explicitly requested by the subscriber or user to provide that service. They are not used for further purposes and are normally installed directly by the owner or operator of the website. Cookies can be divided into navigation or session cookies, which guarantee normal navigation and use of the website (allowing, for example, to make a purchase or authenticate to access reserved areas); analytical cookies, similar to technical ones, used directly by the operator of the site to collect information on the number of users and how they visit the site; function cookies, which allow the user to browse according to a series of selected criteria (for example, language, products selected for purchase) in order to improve the service provided.
